- 1. Call to Order: Meeting was called to order at 3:04 pm by Vice Chairman David Futcher

Motion to approve and accept the maintenance proposal for 2012 made by Board Member Sorrell, seconded (with questions about why we need to approve it) by Board Member Botero, motion passed.
- **6. Airport Manager** We are working with the jail crew and are chipping up the trees on the far west side of the airport and will be at it again on Friday as well.

Talked with Jack Ripplinger at Burlington Northern Santa Fe and the gates are still on the table in the city's favor.

Roof repairs will start Monday December 12, 2011, unsure which side they will start on.

We have fake coyotes at the ends of the airport and they seem to be keeping some birds away.

Discussions: Question was asked about the hangars that are going to be torn down and if any modifications could be made to save them. David Sypher advised the board that there is a row of Sullivan Hangars that will be torn down in the next 3-5 years as they are in the Part 77 air space. Also there are two private buildings that are included in the Part 77 air space as well.

Mr. Quick asked about the economy type hangars.	Public Works Director Sypher told him that they
would be built per the Master Plan and that the Su	llivan Hangars would not be torn down until the
economy type hangars were built.
