Hazel St. Overpass - Meeting with FAA and city engineers is scheduled for next week regarding the approval of giving back Douglas St. and allowing a corner of the RPZ to be encroached upon.

Fuel Tank Project - Fuel placed in the tanks on August 7th. The fuel farm is fully operational and able to sell fuel. Deconstruction of the old fuel farm starts Monday, August 19, 2024.

Runway Replacement - No updates as of today.

Tractor and mower deck were delivered yesterday.

Airport truck. Tractor and mower deck invoice came in \$54,134.83 lower than budgeted. Currently identifying a replacement truck through the State Bid process outfitted with the light kit, radio, and diesel fuel tank in the bed to replace the current truck that is past its service life. New truck not to exceed line-item budget. Current truck and tractor information has been given to the auctioneer and the projected return is set to be much higher than trade in value.
